**Evidence Review & Findings**

**EVP:**

No EVP's reported by any of the team. All of the recorders picked up substantial background noise.

No unusual readings to report; high spikes due to power block in closet of main bedroom.

### **Investigator Feeling / Experiences:**

As with any situation this location prompted several of our team to feel differently at times, there was a heavy feeling noted by several members in the main bedroom area where the apparition was sighted. A distinct feeling of nausea was noted by Chris and Deana while leaning against a dresser in the child's room. During Jeff's clearing a distinct lift in the pressure of the master bedroom was also felt.

### **Final:**

Our observation of the residence did have a distinct feeling for some of our membership. The sensitive on hand did pick up on several interesting notions that fit with the homeowners experiences and observations and were able to confirm the presence of at least one of the apparitions without any prior knowledge of the activity prior to the investigation. However, due to the fact that there was nothing captured as far as physical evidence we cannot at this time conclude that any activity is present at this location. The home was cleansed and a spirit release was performed by the sensitive on hand. The homeowners were counseled on how to better protect the home from spiritual activity from Rita.
