Evidence Review & Findings

EVP:

Cassette Recorder "stationary": Upon review no evidence found.

Digital:

Upon review of all submitted digital evidence a single response was noted by one of our investigators. During standard EVP questioning an auditory response to a question was heard (whisper/male voice) the investigators present during the time of the recording do not match the voice heard on the recording. (Verified by video review) This was the only EVP evidence caught at the location.

Video:

HI-8: (Stationary) No evidence to report.

Mini DV :(Stationary) After review of all of the discs, several “light” anomalies with irregular and intelligent flight patterns were noted during both of the drum sessions as well as the end audio vigil. These anomalies streak across the screen in different directions as well as intersect at times. We cannot explain these occurrences that were caught on the mini, and will conclude these anomalies are not a natural occurrence. We will continue to study this piece.

Photographs:

Several interesting anomalies appeared during our investigation. Pictures of large groups of orbs were taken during both drum sessions; all had remained localized and team members verified that all fans and ducting had been turned off and sealed. One image in particular stands out at the back of the store - perhaps a vortex? Only one camera malfunction (battery drain) was noted at this site but it was not verified by the investigator.

EMF:

Stationary EMF meter present. No unusual readings to report.

Thermal:

Ambient device was used; several different areas in the store had temperature changes noted.

Investigator Feelings / Experiences:

(Note: Personal experiences cannot in itself determine paranormal activity in a location, unless documented by video or audio equipment)

Amy – Several feelings of apprehension and heaviness noted in the back room of the location an urge to leave the area was felt throughout the night. Same experience noted in the front area of the location.

Russ – Distinct temperature changes noted, as well as movement on a stationary object in the front of the store, movement intensified with close contact of object. Orbs photographed in several areas.

Alyssa – Cold sensation felt with physical reaction and felt a contact on her neck while near the back of the location. While in the backroom a low crackling sound was heard then stopped abruptly; this was noted by several others present.

Jo – During the last vigil a movement like a bird was spotted moving from the front of the store to the back near the ceiling, this was noted twice by the investigator.

Marcel – Witnessed a stationary recorder fall off of the Hi – 8 device.

Kyle – Had a physical reaction when he entered the back room of the store, feeling nauseous; upon leaving the site he felt better immediately. Later upon entering the same area, he experienced no reaction.

Chris – No experiences to note.

Wendy - Feelings of heaviness noted in the backroom. Heard a knocking sound during the quiet vigil. Pictures of orbs taken.

Wayne – No experiences to note.

Deanna – No experiences to note.

Final:

The membership has reviewed and submitted all evidence that were crucial in the findings of this report. The business that was the target of this investigation is a metaphysical shop and *could* be a conduit for happenings of a paranormal nature. Several members of the team did have experiences while in the shop; additionally, there were several interesting anomalies captured via digital camera, video, and digital recording. We did not capture any significant evidence to suggest that this location be a hotspot for paranormal activity, however with the reviewed evidence we do conclude that several unexplainable events did occur and were recorded with our equipment on hand. We will upon permission of the client be returning to this location for a follow up investigation.
